1. INTRODUCTION

This document provides all multicast and TCP/IP addresses required to access the Euronext Optiq® Production and Disaster Recovery (DR) for Optiq Snapshot and MDG Lite services.

The Euronext Optiq® Production environment (PROD) is located in Bergamo and the Disaster Recovery (DR) environment is located at St. Denis. The Production Primary (P) and Secondary (S) Source IP Address ranges are provided in this document for the live and standby systems as part of the High Availability mechanism.

The document should be read in conjunction with the Euronext Cash and Derivatives Markets – Optiq MDG External User Acceptance Connectivity document, in order to derive a combined view of the Euronext Production and DR available services.

Customers are requested to allow the Production Primary, Production Secondary and Disaster Recovery (DR) Source IP Address ranges through their Firewalls.
